The Committee voted unanimously to submit the three candidates to the Board of Governors. The Board submits nominations to the Court for its ultimate appointment. The invited guests departed the meeting.

V. Board of Legal Specialization – Law School Representative

The Committee screened the one application received and voted unanimously to recommend Heather Spielmaker, Assistant Dean of Career Development, UA Law School, to the Board of Governors.
