- CFO Kathy Gerhart stated that the member in question had paid his fees that morning.
- Mr. Smith withdrew his motion.

MOTION: Bob McWhirter moved, Mignonne Hollis seconded and the motion carried unanimously to approve the list of Suspensions for Non-Compliance with Annual Membership Fee and/or Trust Account Compliance as presented to the Board.

MOTION: Bob McWhirter moved, Chris Russell seconded and the motion carried unanimously to approve the May 19, 2023 Board meeting minutes.

Workplace DEI Survey Timeline – Jennifer Rebholz

- Discussion regarding how to get more participation in responding to DEI surveys in the future
- Results were posted on the Bar's website; share via social media, reach out to Affinity Bars.
- Ms. Rebholz reiterated that the survey is baseline and a work in progress and will improve.
- Denis Fitzgibbons asked whether classes at the law schools are more diverse. Victoria Ames and Leah Won indicated they were and will share data with the Board.

Finance and Audit Committee - Kelsi Lane and Kathy Gerhart

The following updates are based on operating results through 1st Quarter 2023 – final income statement will be issued by tomorrow afternoon.

- Revenues
 - ➤ Overall, revenues under budget, but not by operationally significant amount so far.
 - ➤ Annual fees collections within normal variance of budget anticipate \$10.2 million of \$10.3 million.
 - ➤ Pro Hac Vice, Board of Legal Specialization Fees, Rental Revenues, significant CLE programs and significant new publications are all tracking in line with budget.
 - MCLE late fees have exceeded budget by around \$40,000.
 - Ad Sales are less than budget by around \$30,000.
 - ➤ For 2nd quarter, will be paying close attention to continuing CLE and Ad Sales trends. Do anticipate Convention coming in under budget.
- Expenses
 - ➤ Personnel costs are less than budgeted for 1st quarter, even given budgeted vacancy factor of 3.5%.
 - ➤ Depreciation is within \$4K of budget
- Operating expenses are less than budgeted by around \$215K. For 2nd quarter, will be determining permanent versus timing, based on needs and continued revenue trends

<u>Legislative Update</u> – Joel England and Joe Hengemuehler

- SB 1435 was on the final read calendar that morning, was voted on and passed during the board meeting and will be sent to the Governor.
 - Mr. England to send reminder to the Governor's General Counsel of the Bar's (and Court's and Bar Foundation's) request to veto the bill.
 - Discussion regarding individuals reaching out to elected officials, Governor's new Chief of Staff, others, and the potential for that to backfire.; members asked to contact the CEO and the CCO for talking points and any plans to engage with the Executive or Legislative Branch.
