### 1. Call to Order – Ted Schmidt

President Schmidt called the meeting to order at 8:30 a.m.

# 2. Call to the Public - Ted Schmidt

President Schmidt made a Call to the Public and hearing nothing, moved on to the next item on the agenda.

#### 4. CEO's Report – Joel England

- CEO England reported attending the All Hands Meeting alongside President Ted Schmidt, and Chief of Staff/Director of Community Impact Noah Coakley. Discussions focused on access to justice, a letter signed by President Schmidt in support of LSC (Legal Services Corporation) funding, and strategies to improve legal representation and resources for individuals unable to afford legal services.
- CEO England announced to the Board that the New Member Orientation that took place at the State Bar of Arizona office/hybrid on June 12th was successful
- CEO England encouraged the Board members interest for the upcoming vacancy, replacing Diandra Day Benally's BOG seats on the Foundation's board and the ABA House of Delegates.

# 5. Nominating Committee / Election of Officers – Benjamin Taylor

Genna Barela, Manager of Board Operations, presented on behalf of Benjamin Taylor. The Board was prepared to vote via ballot to determine the upcoming Secretary/Treasurer for the Board of Governors 2025- 2026, this vote included two candidates, Robert McWhirter and D. Christopher Russell.

The Board did not move forward with a ballot vote as Robert McWhirter withdrew his candidacy at the June 23 Board meeting, leaving D. Christopher Russell as the one remaining candidate for the Secretary/Treasurer officer position.

#### 6. Appointments Committee – Doreen McPaul

Doreen McPaul presented the Appointment Committee's unofficial recommendation to the Board for American Bar Association (ABA) House of Delegates (HOD), with the two vacancies, one specific to Young Lawyers Division (YLD).

The committee brought forward Tiffany Tom (Incumbent) (Arizona Department of Environmental Quality, Pima County) and Chelsi Lynch (Rue Law LLC, Pinal County) as a District 1 representative of the YLD for the ABA HOD.

## 7. Rule of Law Working Group – Kelsi Lane

Kelsi Lane presented two action items to the Board. The working group recommends the State Bar organize and manage a Rule of Law Day event in coordination with the court. The event would include various speakers and attending lawyers would be invited to gather on the courthouse steps and retake the oath they swore upon being admitted to the practice of law.

The working group also recommends to the State Bar of Arizona Board of Governors that the general public would benefit from State Bar organized opportunities for civic education by developing an

Arizona Lawyer Civic Ambassador Program. These attorney ambassadors would have a pre-prepared program to educate the public regarding our system of government, including the important role that courts play in maintaining a civil society (Rule of Law Task Force Working Group Final Report, 2025). The Working Group will be reaching out to the Foundation for assistance with the materials.

# 9. Proposed Amendments to State Bar Bylaws – Lisa Panahi, Sam Saks

Sam Saks presented proposed amendments to the State Bar Bylaws, developed by himself, Lisa Panahi, and their team. The updates include revised references to Rule 32, an updated mission statement aligned with the Arizona Supreme Court, and clarification of decision-making authority for Executive Council members and Board of Governors officers.

This was presented to the Board following the 30-day notice rule.

## 10. Wellness Services Update - Joel England

Joel England provided an update on the Wellness Services Program, noting ongoing efforts to establish an independent nonprofit to support lawyers. He reminded the Board that funds from the Opportunity Fund were approved to support this initiative. Further updates to follow.
