The award was created to recognize a lawyer who thinks creatively about client issues and solutions. A lawyer who takes the long view and keeps in mind the community of which we are all a part of.

You may nominate an individual if you are an active Environmental and Natural Resources Section member, or are on the Executive Council. <u>To submit a nomination</u>, <u>please provide the following information by Friday</u>, <u>January 30</u>, <u>2026</u>:

- Nomination Form
- Curriculum vitae for the nominee
- Essay describing why you believe the Candidate is qualified for the Brophy Award
- One or more letter(s) of recommendation from other individuals with nominee's qualifications for the Brophy Award
