- Application deadline April 30; committee will be formed so members can provide feedback about the Bar and find resolutions to issues
- Lengthy discussion ensued regarding new committee's role regarding discipline cases. Board discussed limitations on discussing open discipline cases, and role of Discipline System Oversight Committee to be the place to discuss issues with system, including review of closed cases, and role to recommend changes and improvements. Discussed Court's role as overall authority for the system and limits on the role of the Board of Governors. Discussed rules for public comment and importance for Board to hear from both sides on an issue.

  - ➤ Following up on Public Governor Cedric Dave's suggestion that quarterly reports be given to the Board; COS/DEI Director Noah Coakley is compiling that data for future updates
- Attended:
  - ➤ ABA Bar Leadership Institute leadership training with Doreen McPaul
    - o Ms. McPaul expressed her appreciation for the great opportunity to attend practical sessions and discuss difficult Bar-related topics and network with peers
  - Coconino County Bar Association presentation with the president; a fun opportunity to engage with local attorneys
  - ➤ WSBC: Board approved CEO's designation as secretary/treasurer and his coordination of these annual conferences for the next couple of years. Big thanks to Executive Assistant Deanna Commack for all her work in organizing the three-day event and the I.T. Department for redesigning the WSBC website.
  - ➤ ABA Day on The Hill shout out to CCO Joe Hengemuehler for his coordination of this event for Arizona's delegation
  - Access to Justice Commission Meeting
    - Requested a written Comment be submitted in opposition to the Goldwater Petition and the Commission agreed; Arizona Bar Foundation has done so; others committed to same: Arizona Black Bar, Arizona Asian American Bar, other affinity bars, managing partners of large law firms, 30 past State Bar presidents.

### <u>Discipline System Survey Update</u> - Dr. Shannon Portillo

CEO Joel England recommended entering Executive Session.

**EXECUTIVE SESSION:** Jessica Sanchez moved, Bob McWhirter seconded and the motion carried unanimously at 9:00 a.m. The Board reconvened in Open Session at 10:25 a.m.

## **Updates**

- Uniform Law Commission Tim Berg
  - > Two uniform laws signed by the Governor:
    - o Partition of Estates (heirs property)
    - o Unlawful Restriction in Land Records (can be redacted from title)
  - Currently working on benefits of creditors, mortgage modifications, virtual currency, conflicting laws in trust/estates, etc.
    - o Feedback/comments always welcome
  - Judicial interviews project: Family Law best practices for uniformity regarding custody cases
  - Yearend Omnibus: Associations Act (Business Law)
- Arizona Commission on Access to Justice
  - ➤ Rule Change Petition R-24-0006, filed by the Commission, seeks to add a comment to the Arizona Code of Judicial Conduct Rule 2.6, specifying certain things that a judicial officer can do to ensure a self-represented litigant's right to be heard.

#### Rules Review Committee - Lisa Panahi

(Comments by Veronika Fabian and Joshua Smith, Criminal Practice & Procedure Committee; Mike Ferrell, Civil Practice & Procedure Committee)

- Proposed Comment to R-24-0026, Petition to Amend Rule 49(d)(1), Ariz. R. Civ. P. and Rule 18.1, Ariz. R. Crim. P.
  - Petition seeks to amend the civil and criminal rules to require that in §13-4521 proceedings, the criminal rules re the number of jurors and unanimity control.
  - ➤ Civil Practice & Procedure Committee recommended that the State Bar oppose the Petition.
- Proposed Comment to R-24-0010, Petition to Amend Rule 10.2(a), Ariz. R. Crim. P.
  - Petition seeks to amend the criminal rules to correct an "imbalance between prosecutors and defendants" but instead recreates the imbalance in favor of the defendant by removing the State's access to relief.
  - The Criminal Practice & Procedure Committee recommended opposing the Petition.
- Proposed Comment to R-24-0016, Petition to Amend Rules 17.4 and 38, Ariz. R. Crim. P.
  - Petition seeks to enact a sweeping change to the rules by creating a restorative justice conference as a means of resolving cases with little to no input from stakeholders.
  - ➤ The Criminal Practice & Procedure Committee recommended supporting the Petition insofar as it proposes the formation of a task force only.
- Proposed Comment to R-24-0022, Petition to Amend Rule 11(b)(1), Ariz. R. P. Eviction Actions
  - Petition seeks to amend the rules to require the court in an eviction action to recall a case at the end of a calendar in which the plaintiff or defendant did not appear or respond after an initial call.

- ➤ The Civil Practice & Procedure Committee recommended opposing the Petition and advocated the Supreme Court create a task force or working group to determine the best method to avoid unnecessary defaults in eviction actions.
- Proposed Comment to R-24-0024, Petition to Amend Rule 5(d), Ariz. R. P. Eviction Actions
  - ➤ Petition seeks to amend rules to require verification that landlords comply with the CARES Act in order to proceed with a state special action.
  - ➤ The Civil Practice & Procedure Committee recommended opposing the Petition as drafted but suggested alternative language to amend the rule.
- Proposed Comment to R-24-0028, Petition to Amend Rule 34(f), Ariz. R. Sup. Ct.
  - Petition seeks to amend rules relating to the process for attorneys admitted in other states to become authorized to practice in Arizona.
  - State Bar officers recommended filing a comment in opposition to the proposal to eliminate the active practice requirement and the proposal to substitute another jurisdiction's character and fitness examination for Arizona's current process but took no position on the other proposed amendments.
- Proposed Comment to R-24-0030, Petition to Amend Rule 32(b) and (c), Ariz. R. Sup. Ct.
  - ➤ Petition seeks to amend rules to eliminate State Bar membership dues for non-regulatory functions.
  - > State Bar staff recommended filing a comment in opposition.

**MOTION:** Bob McWhirter moved, Jessica Sanchez seconded and the motion carried over two abstentions to approve the Rules Review Committee report and recommendations as presented.

### Ethics Hotline Member Service - Lisa Panahi

- Overview of the Ethics Hotline service and statistics were provided:
  - ➤ Hotline deals with prospective issues and can mitigate potential discipline
  - Non-binding advice and guidance provided to members quickly, returning calls within one-two days (unless "urgent")
  - > Calls are not recorded but written summarized notes are maintained and are confidential

- ➤ 2017 Task Force agreed that the Hotline provides valuable services and recommended the Hotline remain intact
- ➤ Over the past three years, 5,723 calls received
- Currently averaging six calls daily
- There are two other practice hotlines: Practice 2.0 and Trust Account Hotline
- ➤ Bar's Ethics Counsel is key personnel with volunteers providing backup
- ➤ Chief Bar Counsel Maret Vessella indicated that out of 28,000 discipline charges, about 15/20 involved Hotline callers
  - O A caller must authorize the release of the notes from their call for review by the Lawyer Regulation Office
  - A caller's good faith effort to mitigate potential ethics issues rarely results in discipline; great deference given to members who received advice
- ➤ Could an AI product be utilized for ethics advice 24/7 by members?
- ➤ How to increase use of the Hotline? Are more resources (staffing) needed?

**MOTION:** Sam Saks moved and Dave Byers seconded a motion to form a task force to study ways to strengthen the Hotline service and expand it so it's more widely used. The motion failed to pass.

## **Bylaw Amendment** - Benjamin Taylor

- The Board discussed Bylaw 6.02 and 7.05
- A bylaw change must mirror Rule 32 since the Rules trump the bylaws, thus a Rule change is the first step
- Include this matter in the bylaws review scheduled for 2025
- No action taken at this time on this matter

## **<u>Discrimination Complaint Policy</u>** - Jessica Sanchez

- The D&I Panel has completed it work with regard to proposed amendments to the current Board policy
- Amendments summarized

**MOTION:** Jessica Sanchez moved, Elizabeth Schmitt seconded and the motion to approve the proposed amendments to the Board's Discrimination Complaint Policy carried unanimously.

### Finance and Audit Committee - Doreen McPaul and Jessica Iennarella

- Year-end December 31, 2023 Financial Statements
  - ➤ In February predicted a \$1.3M surplus, however, the surplus ended up being \$1.4M.
  - Annual audit begins first week in May.

### **Legislative Update** - Janna Day

- SB1145 (Political Speech Rights) dead at this point
- SB1471 (Complaints Against SBA Members; Dismissal) dead at this point
  - Mr. Byers indicated that next week he will file a Petition with the Court requesting it take up this matter on an emergency basis
- SB1589 (Attorneys; court-appointed professionals; juries) dead at this point
- SB1214 (CLE) Signed by the Governor on 3/25/24

- SCR1044 (Judges' Terms of "Good Behavior") alive; ballot referrals being held in Rules in the opposite chambers until leadership determines which ones they're going to let continue to the ballot; just "Do Pass."
- Strike All Amendments deadline has passed with no talk of revival.
