## **Legislative Update** – Joel England

- Janna Dav
  - ➤ Day 100 was on Tuesday; both chambers have to agree to extend; might be mid-May until sine die
  - Reminder that over the past many years all Bar-supported bills have passed unanimously; Bar entities work diligently to provide bills that are ready for Legislative action, e.g., LLC Act
- SB 1565: About making the Bar voluntary
  - ➤ Hasn't moved in a month
  - ➤ Has enough opponents that it probably won't move
- SB 1566: Regarding discipline
  - ➤ A little movement on this one an amendment to remove damages portion and a few other tweaks were made
  - Continue to work with Democrats and a handful of Republicans that are opposed to both bills
- Jennifer Rebholz: Please let CEO England, Janna Day or her know if you speak to a lawmaker; it helps to coordinate the Bar's efforts.

## Rule 38 – Law School Professors - Roberta Tepper

With regard to law professors previously certified under Rule 38 and who had their certification grandfathered in under the new version of Rule 38, their noncompliance with the requirement for annual fee payments for 2020 and 2021, and their noncompliance for the 2020-21, and 2021-22 CLE years, will be forgiven. They will have to pay annual fees for 2022, but the late fee will be waived. They will have to comply with the MCLE requirements starting with the 2022-23 CLE year.

## Litigation Against Mandatory Bars - Lisa M. Panahi

- Three petitions for certiorari, asking the Court to look at *Keller* and the constitutionality of the integrated bar, were recently denied by the U.S. Supreme Court.
- However, other similar litigation is still working its way through the federal court system. Our office will continue to monitor and report significant updates.
