#### **President's Report** – Jennifer Rebholz

- Continuing to meet with affinity/partner bar associations along with CEO Joel England.
- Attended the retirement event for Mike Baumstark, Deputy Director of the Administrative Office of the Courts.
- Senior Lawyer's Working Group (WG): Will soon appoint the WG to address the issue of fees; working to identify the chair of the WG.
- Convention planning is in progress.
- Attending the Judicial Conference in Flagstaff next week.
- Hon. Brian Furuya's Investiture is October 29, 2021; open invitation to the Board in the meeting materials.

### **CEO's Report** – Joel England

- Continuing to have one-on-one, virtual conversations with Board members.
- Also attended Mike Baumstark's retirement celebration at the Court; thanked him for his efforts; and announced his replacement, Marcus Reinkensmeyer.
- Mandatory Bar Litigation Update: Have been monitoring petitions before the U.S. Supreme Court to see if guidance was offered on what was considered germane and non-germane activity; on October 4, 2021, the U.S.S.C. denied *cert* in the 9<sup>th</sup> Circuit Crowe/Gruber case effecting the Oregon State Bar. Litigation continues in the lower courts.
- Along with President Rebholz, continuing to meet with affinity/partner bar associations; welcomes the feedback from these conversations.
- Completed Ethics training sessions with all staff members.
- Continuing with budget meetings; recently met with the Human Resources Subcommittee;
   Finance & Audit Committee approved the HR recommendations and will look at the entire budget next month at its meeting.
- Spoke at Luke Air Force Base's training for its lawyers; enjoyed speaking about the State Bar and how it supports veterans and military members.
- Participated in three days of staff appreciation lunches; format changed from in-person to grab-and-go box lunches during continued pandemic protocols.
- Alberto Rodriquez, the State Bar's Public Relations and Marketing Manager, is leaving the Bar as of today and begins a new position on Monday as the Court's Communications Officer.

Congressional Oversight and Executive Immunity

#### <u>The Bar's Financial Structure</u> – David Rosenbaum, Kathy Gerhart

Reviewing the financial structure today since the budget will be presented at the December Board Meeting. This topic is generally covered at the Board retreat, which was cancelled this year. The following areas were reviewed:

- Revenues: Numbers are from 2020 since they are finalized; note that it is an anomaly due to COVID; 67% of revenue is from mandatory fees.
- Expenses: Personnel costs as a percentage of total expenses in 2020 were higher due to COVID; travel, conferences, conventions & meetings were significantly less due to virtual environment. In 2020 we did see an increase in expenses for vacation accruals.
- Five Year Projections
  - Reviewed revenue and expense projection assumptions
  - Reviewed projected surplus/loss for 2022 2026
- Reviewed Current Capital and Annual Fees Reserve Policies.
- Funds invested with Vanguard
- As of October 13, 2021 reserve balances were:

Capital Reserve \$2,725KAnnual Fees Reserve \$4,438K

• Key Financial Roles/Responsibilities were reviewed.

### **Board's Fiduciary Responsibilities** – Jennifer Rebholz, Rick Palmatier

- Duty of Care: Show up, be prepared and engaged
- Duty of Loyalty: Board member should divulge a conflict of interest; respect the validity of the Board's choice once a vote is taken (Board speaks with one voice).
- Act in good faith; exercise the care of an ordinarily prudent person; act with the reasonable belief of those actions being in the best interests of the corporation
- External:
  - Arizona Nonprofit Corporations Act: General standards for directors and standards of conduct for officers; defined conflict of interest.
  - Rule 32:
    - Organization of the State Bar of Arizona is to "serve and protect the public ... provision of legal services and access to justice."
    - o Powers of Board
    - o The Conflict of Interest forms are signed annually.
    - Board members can talk among themselves; but be cautious about the number of members doing so and attempting to reach a consensus about decisions outside the full Board experience.
- Internal:
  - ➤ Articles of Incorporation & Bylaws
  - ➤ Board of Governors Code of Conduct statement and Conflict of Interest policy
  - ➤ Board policy restricting Board members' representation of lawyer-respondents, and also the availability of the Ethics Hotline to assist with prospective conduct.
