III. Approval of Minutes – October 25th meeting minutes:

IV. 2019 Operating Budget – 2nd Draft

Individuals addressing the Committee: Kathy Gerhart

Discussion: Kathy G. reported that the 2019 Budget second draft saw insignificant changes. There was a reduction in auditing fees, which was offset by miscellaneous expense increases. The overall difference resulted in no change to the \$6K surplus reflected in the 1st draft of the budget presented in October 2018 to the F&AC. The current draft is in-line with BOG-approved 2019 Budget Memorandum.

V. 2019-2023 Capital Budget – 2nd Draft

Individuals addressing the Committee: Kathy Gerhart

Discussion: Kathy G. reviewed the updated 2019 Capital Expenditures totaling \$1,006K, which included both mission-critical and mission-enhancing projects that were identified in the October 25th F&AC meeting. Comparatively, the 2019-2023 budget is currently projecting \$772k less in capital expenditures for a five year period than was projected for 2018-2022 capital budget. **Motion/ moved by:** Anna T. motioned to approve the 2019 Capital Budget, and submit to the BOG for final approval at the December 6th meeting.

VI. Five-Year Projections

Individuals addressing the Committee: Kathy Gerhart

Discussion: Kathy G. reviewed the five year projections, noting that these projections reflect business-as-usual and do not take into consideration any Go Bold Initiatives for revenue generation or cost reductions. The business as usual model projections show that there would be a \$300k loss in 2020 that would continue to grow year after year. Management's implementation of the Go Bold Initiatives in 2019 are being developed to help mitigate the losses.

VII. October 2018 SBA Financial Statements - Update

Individuals addressing the Committee: Kathy Gerhart

Discussion: For the ten months ended October 31, 2018, the Bar's income statement generated a surplus of \$164K excluding Sections. The surplus year-to-date is \$140K more than budgeted. This is due to \$101K more in revenues and \$39K less in expenses than budget. Sections Activity reported a year-to-date surplus of \$46K compared to a budgeted deficit of \$33K.
